- you immediately report changes or deficiencies that occur during the use of the sightseeing posture

It is forbidden:

- smoke inside the sitting area
- throw cigarette butts or the like on the terrace and through the railing
- use luminaires other than those installed (except battery luminaires)
- enter the sitting area under the influence of alcohol or under the influence of addictive substances
- to bring valuable possessions to the possession, but only movables necessary for his visit

Bad weather:

- in case of unfavorable weather during the stay (storm, strong wind...), when Meteo predicts very unfavorable weather and wind speed / gusts more than 90 km / h, the operator will warn guests with the possibility of moving in the Green Valley in Chotýšany accommodations. In this case, the visitor is entitled to another night at the "Tree House" sitting for half price, in accordance with the rental plan for the next 12 calendar months.
- if the visitor does not heed the warning about bad weather, he declares that he will spend the night in possession at his own risk and responsibility.
